

Boston Capital Reissue of 2018 K-1s

If you downloaded your 2018 K-1 from our website you are NOT affected. If you called our Investor Services Department to obtain a K-1 you are NOT affected and may use these K-1s to file your 2018 taxes.

If you received your K-1 through regular USPS mail you will receive a reissued K-1 that will mail out by March 27th. The new K-1 will come with the letter on page 2 of this notification specifying the K-1 is a reissue.
